# Foreword

When Student Sponsorship Programme (SSP) was founded in 2000 few could've imagined that the programme would be more relevant today than it was then. As we reflect on the last five years of the programme, it is abundantly clear that the work and objectives of SSP have become more critical than ever before. In South Africa, education is meant to be the great equalizer, but access to quality education has become increasingly stratified. The chasm between those that can afford quality education and those who can't has increased, and it poses a significant threat to social cohesion and progress, and greatly contributes to the evident inequities most South Africans face. However, even in this challenging landscape, SSP has stood strong, dedicated to providing comprehensive support to those who need it most, the gifted young minds that we prime to become leaders. The verifiable impact that is demonstrated on this report shows SSP's scholarship as a beacon of hope amidst the storm of inequality. Through tireless efforts and a supportive donor network, SSP has not only increased graduation rates but also fostered transformative changes in the lives of alumni, current scholars, partner schools and families within our community.

In this multi-year report, we look back at the admirable performance of our recent graduates, beginning with a view of the matric performance from 2018 to 2022. This is an important view to have as most of the cohorts in the timeline were affected by the pandemic and learning was interrupted – however their consistent performance is proof of their determination and resilience (Page 5). Presently, our most promising scholar in the Class of 2023 is Anoyolo Lose, read about her SSP journey and her awe-inspiring accolades to date – Anoyolo's story is a significant affirmation of the length and miles the SSP recruitment outreach goes to find talent, giving opportunities to learners who will change the landscape of their rural villages and forgotten communities (Page 13). We acknowledge the SSP parents who through their own unwavering support and nurturing of their children took the time to write how the programme changed their lives (Page 15) – the success of a scholar is guaranteed when they have a supportive parental unit at home.





# Remember her name:

Anoyolo Lose!

Clarendon School for Girls - Class of 2023

Qomfo Primary, set in the heart of Qomfo village, a homestead near Debe Neck, 90 kilometers from East London in the Eastern Cape, was managed by two determined teachers who taught all the grades R to seven. These dedicated teachers noticed something special in a young Anoyolo Lose, who demonstrated academic promise from a very young age. As Anoyolo progressed through her grades, receiving academic awards in every grade, she herself became a 'teacher' to the lower foundation-phase grades. During her grade six and seven years, she taught grade ones and twos after her lessons were done for the day, she herself being one of only 22 learners in the entire school.

It was Anoyolo's aunt who came across the application forms for the Student Sponsorship Programme (SSP) at a municipal library in King Williams (part of SSPs outreach and recruitment programme). She knew her niece would be an ideal candidate and completed the application. The family found the means to travel the 90 kilometers to and fro for every test, every interview and every camp of the comprehensive SSP assessment process, showing the necessary commitment and familial support. Anoyolo amazed the SSP team throughout the five-step recruitment and selection process. All the long travel, and hard work paid off as Anoyolo was awarded a scholarship to attend Clarendon High School for Girls.

Due to the distance, Anoyolo also enrolled into the boarding school at Clarendon Girls. There were concerns about how Anoyolo would cope with the change in the number of learners in a class, the environment of a new school, while being far from home. These concerns were quickly forgotten, the independence and strength with which Anoyolo was raised quickly shone through and Anoyolo settled in well into her new school and surroundings. That was five years ago, as she is one of SSP's Class of 2023 cohort.

From her very first term (semester) in 2019, Anoyolo finished in the top 5 of her grade and has maintained that status throughout her highschool career, obtaining an academic average of over 90% in every term at Claredon. In June of her grade 11 year 2022, she was awarded the highest award for academics, an Honours blazer for academic achievement. To receive an honours award, a learner is required to achieve over 85% average in five consecutive exam terms. This award is seldom given to a Grade 11 learner. In addition to academics, Anoyolo has proven to be a talented debater. Competing in a number of provincial tournaments and selected as a member of the Eastern Cape Delegation to the National Debate Tournament in 2022 was an indication of Anoyolo's exceptional talent.

Recently, Anoyolo represented SSP at the African Leadership Academy Model Africa Union (ALAMAU) conference in March 2023. She represented Zimbabwe in The Civil Society and Diaspora Development (CSDD) segment of the conference. Her participation, input and insights at the conference was noted by the adjudicators as being remarkable, especially since this was her first time participating in the conference. It has always been Anoyolo's hope to change the cycle of poverty for her family and community, she is dedicated and motivated to see to it and this is her journey to greatness!

I am the proud mother of an SSP Alumni. My name is Lungile Mtshali. We had never heard of SSP. We owe a great deal of gratitude to my husband's friend who introduced this programme to us.

We had just relocated to a new area and SSP came at the right time as we were facing some financial difficulties. When the late Yvonne Lushaba informed us that Sanele was accepted into the programme, we were both excited and nervous. He was going to be meeting top-performing learners at one of the top high schools in the country and we honestly had no idea what to expect.

Sanele strived to be one of the school's top achievers and continued to excel. He participated in the school's Olympiads and competed against top learners from other schools. His leadership qualities first became evident when he was elected as a head boy in primary school and then became a prefect and boarding house representative in high school. He is also very passionate about sports and took part in various sporting codes at a top school level well into his tertiary years.

The SSP experience shaped our son's life and taught him values such as responsibility, accountability, independence, respect and coexisting with society at large. The camps he attended during the school holidays helped him maintain good grades and he performed well in his matric year.

He also had a mentor in the early stages of his high school career who motivated him to take his studies seriously from the beginning. We need to mention that the support he received from his sponsor, Mr David Smollan, played a big role in ensuring his success throughout his professional life. They were (and continue to be) in contact with each other and we are grateful to have met him through this programme.

We would like to encourage other SSP parents to plough back into the coffers of this programme. Although we have not been involved in the volunteer initiatives, we believe that keeping in touch with the SSP family will make a positive difference in some way. I have referred a former colleague to the programme, and his son excelled so much in this programme that after matric he was offered financial assistance for his tertiary studies by more than 3 companies.

SSP should continue getting donors/sponsors to help children, particularly those who come from disadvantaged communities. This programme helps them build their future and once they form part of the working class, they should also give back by becoming mentors, sponsors or donors. We make it a point to share information about SSP with parents who have children in grade six every year when applications for recruits are open.

## My Journey as an SSP Parent

My name is Theressa Fiyo and I'm Jocelyne's mother. We were in the Student Sponsorship Programme from 2017 to 2021, when Jocelyne matriculated from Sacred Heart College. I remember the day I received the message from SSP informing me that she got the scholarship in 2016. We were walking on our way back from her primary school and I felt incredibly grateful. We were both so happy to have gotten such a huge opportunity.

From the get-go, our experience with SSP was a very good one. For me, especially, it was a relief to know that my child was going to a good school. She learned how to be independent

and for me, it was wonderful to see her become a responsible young lady.

Throughout our experience, SSP supported us with everything, from school fees to uniforms and even stationery. I did not have to worry about anything. This is the very support that helped my child get a better education and exposed her to a lot of other opportunities.

In addition to that, the relationship between myself and our SPO was great. SSP did not only focus on academics, but also on the well-being of the students and parents. My child was also introduced to a mentor who guided her for most of their relationship.

I, as a parent, would like to encourage other parents to apply for the scholarship and be involved throughout the journey. I would also like to encourage donors and sponsors to continue to fund this program as it is a great cause. It goes a long way, and my child would not be where she is today without the help.

# Recruitment Model

#### **Outreach**:

SSP recruit high-performing scholars through an extensive community outreach programme that connects feeder schools, community centres, libraries and after-school programmes with an opportunity to gain access to quality education. As a result of these partnerships, SSP has a wide reach into rural areas, peri-urban areas, townships and urban areas to find high-potential scholars.

#### **Selection Process:**

Applicants undergo a rigours 5-step selection process in the form of baseline tests in numeracy and literacy, social interviews with parents and/ or guardian(s), a differential aptitude assessments test (DAT) and an interactive camp to observe applicants with the aim to get the most consistent and high-potential candidates to propose to our partner schools.

#### Placement:

The recruitment team gathers the data of each applicant and reviews it to make a submission in our partner schools for placement a year in advance of Grade 8. Each applicant is carefully considered to understand their unique needs,

potential and their attributes – with the aim to align an applicant with a school best suited to enable their growth and development.

#### **Scholarship Award:**

Upon successful completion of the programme and partner school interviews applicants are awarded a 5-year high school scholarship and begin their "future leader" journey comprised of a suite of comprehensive support and development.

- Have demonstrated leadership, sport and culture potential.
- Be community service oriented.
- Demonstrate financial need by parent(s) and/or guardian.
- Have committed parent(s) and/or guardian.

In the heart of Alexandra, a vibrant township in Johannesburg, a remarkable educational initiative has taken root, breaking down barriers and providing boys with access to quality education. St David's Marist Inanda, a renowned institution with a rich history of academic excellence, has opened a satellite high school campus in Alexandra, fulfilling the vision of the late Fr Ronald Cairns OMI and continuing the legacy of the Sisters of the Holy Cross. The inauguration of St David's Marist Inanda (Alexandra Campus) in January 2022 marked a significant milestone in pursuing academic excellence and accessibility to quality education for boys in Alexandra and the surrounding areas. This collaborative effort between St David's Marist Inanda and St Hubert's Catholic Parish aims to bridge the gap between Sandton and Alexandra, fostering a new education model that brings hope and opportunity to the local community.

At St David's Marist Inanda (Alexandra Campus), boys receive a comprehensive educational experience grounded in Catholic

values and the Marist ethos. Inspired by the teachings of the Gospel and the principles of humility, simplicity, and modesty advocated by St Marcellin Champagnat, the school provides a values-based approach that nurtures the development of well-rounded individuals. Boys of all faiths are welcome as the school embraces diversity and inclusivity. # How did you discover the SSP programme and what inspired you to become a mentor?

I think it was here at Absa, we were an SSP donor. I became involved with SSP in 2013 (so ten years ago). Time flies! I was inspired by my appreciation of the role education played in my personal journey. I came from a home that was headed up by a single mother, who had to raise 6 kids on her own after my father died. My mother always emphasised the value of education and I took it to heart. I was a diligent student and I saw education as the best tool to change my life and achieve my goals. I was not mentored or given insight on the journey ahead. I resolved to change that for the people who came after me.

# How would you define the role of a mentor in supporting students through a scholarship journey?

The role of the mentor is not to remove all obstacles but to rather ask questions of the mentee. I almost never answer a question directly. I'm sure that has driven some of my mentees mad! I believe the skill of learning to find the answer and to trust yourself is too valuable to be short circuited. What's wonderful about SSP is being a part of the teenage years of a student, a time of great personal change and watching them learn to be independent. This is the mentor's role, to reinforce and to challenge but ultimately make sure the student has considered all options and is better able to do this in the future when the mentor may not be there. One of my favourite parts of the journey is when they need to choose subjects because they are so young, they often start with "I want to be a lawyer" and this is fine, but the mentor must then ask: "Have you spent time with a lawyer? What kind of injustice can you not stand? How will that fulfi I you?" My first mentee, Lesedi Nkwe, went through this exact exchange with me. I remember we arranged for him to spend time at a law firm where my sister-in-law worked. He went on to study law, so I guess he really wanted to be one!

# What qualities or skills do you believe are essential for an e ective mentor on programmes like SSP?

Communication. You are dealing with teenagers, and they are not always the best at this. So the mentor must pick up this slack. The other one is empathy; it is hard to remember how challenging a scholarship programme is for the students, but you must consider that they are in a different academic and socioeconomic environment in the respective schools, so they'll need time to find themselves. You know when I was a new mentor, I used to be obsessed with academics, but I've since learnt that while those are important it really is about the mentee coming out the other side of the journey.

# How did you establish trust and build a strong relationship with your mentees?

Communication and in-person meetings. Precovid, I used to meet up with them regularly. I think the pandemic badly affected my approach and I must admit to having not spent as much time with the mentees I had around this time. It's important to also draw lines for yourself. You are not a parent and not a peer to the mentee. You earn a different trust, but you can't replace the parents.

Two of your mentees are valedictorians, an excellent achievement, what would you say has been the lesson, for you, in walking the journey with the two scholars?

They deserve all the credit! Lesedi and Lesego were both outstanding scholars and they worked hard and took in the guidance. After them I thought this would always be the outcome. I think the lesson came with a mentee who had different academic outcomes and what I learned is they are all individuals. I can't re-create the outcomes of prior mentees; I can only infl uence and support.

# What has been the common thread between the scholars you have mentored?

All of them were boys! The common thread is they were all so different. I learnt from all of them, they challenged some notions I had about being a young man and I appreciate that. They taught me too and this is true for all my 3 mentees.

# How has mentoring influenced your life in general?

Tremendously. I believe my knowledge and experience is of little use to me, so I share it. Mentoring at SSP is a different thing though, watching the students blossom is rewarding and knowing you helped put someone on a footing for a chance at success is worth it. You know the idea that says if you want to be happy, find and do something that you would do even if you did not get paid? Mentoring is that for me.

# Do you keep in touch with your mentees and what are the highlights of your relationship beyond SSP?

I do but not as much as I should. What's funny is that when they get into university, they become too busy with university life but the occasional check-ins are still nice.



# Busi Sibeko

Analyst at the South African Parliamentary Budget Office, Cape Town

Busi Sibeko is an economist and researcher. She was an SSP scholar at the American International School of South Africa where she graduated in 2012. She went on to acquire a bachelor's degree in Economics from Duke University and a Masters in the Political Economy of Development from SOAS, University of London. She currently works as a public finance analyst for the Parliamentary Budget Office of South Africa.

She was previously at the Institute for Economic Justice (IEJ) where her research focus was macroeconomic policy, including participatory feminist budgeting. She was the co-Chair of the Budget Justice Coalition, comprised of 14+ civil society organisations. She also provided research support to the labour constituency. During her time at the IEJ, Busi published a number, including The Cost Austerity: Lessons for South Africa and A fiscal stimulus for South Africa. Her work has been published in the Daily Maverick,

New Frame, Sunday Sun and the Wits University Press amongst others. She also appeared on NewzRoom Africa, SABC news and other news channels advocating for budget justice.

In 2020, Busi was featured in the roundtable series of renowned economists on Rebirthing the Global Economy to Deliver Sustainable Development by the United Nations Secretary General. She also participated in the UN Women expert group which informed the Beyond COVID-19: Feminist Plan (2020). Her most recent works include a paper titled A feminist approach to debt in Africa and co-wrote a paper titled Feminist Proposals on Macroeconomic Policies needed for a COVID-19 Economic Recovery A perspective from the African continent.

She considers herself a feminist political economist in training and is determined to be a part of unwinding structural injustice.

Her research work focuses on black women's historiography with a particular interest in life writing. She is also interested in the African language newspapers of the early 20th century.

Dr Athambile earned her PhD from Rhodes University with a thesis which focuses on the writings of Noni Jabavu and Sisonke Msimang. She has published in a variety of platforms and publications such as the Mail and Guardian, Johannesburg Review of Books, Al Jazeera to name a few as well as academic journals. Her debut collection of poetry written in isiXhosa, Ilifa (Uhlanga Press, 2021) was the winner of the HSS (Humanties and Social Sciences) Awards in 2022. She is the co-author of the children's book series, Imbokodo: Women Who Shape Us (Jacana Media, 2022) together with Dr Xolisa Guzula. The book is a collection of 30 biographies about South African women who

have shaped South Africa's history and the present. Together with Milisuthando Bongela she is co-host and creator of the podcast Umoya: on African Spirituality which was a partnership with Kaya fm. Her latest book is a collaboration with Makhosazana Xaba; a collection of Noni Jabavu's columns from 1977, A Stranger At Home (Tafelberg, 2023).

Dr Athambile has been involved in a variety of education projects such as Molo Mhlaba (a school for girls in Khayelitsha) as the founding board member until 2019. She is a member of bua-lit collective which advocates for African languages as a social justice issue. She was also the co-founder of Asinakuthula Collective which hosted public events and created a digital archive of Black women's histories.


